All entries that have been received have been accepted – an entry list in Class order will be available at scrutiny. The onus is on the Competitor to make sure that he or she is entered in the correct class for the event at Scrutiny.

Mechanical and Documentation Scrutiny will take place between 06:00 hrs and 09:00 on Saturday 1st August 2015 at St Angelo Enniskillen, Co Fermanagh. A Timing Strut <u>MUST</u> be fitted to the front of the vehicle as per MSA Yearbook S 10.9

A Drivers briefing will take place at 09:30 hrs on Saturday 1st August 2015 at St Angelo in the hanger where Scrutiny and Documentation will take place.

Competitors will be given the opportunity to walk or cycle around the route prior to the first official practice timed run which will start at 10:00 hrs. There will be 2 Practice and 3 Official Timed Runs given on the day. Each run consists of 2 laps giving a total of approximately 2.5 miles in length.

The prize giving will take place at the St Angelo Airport Café immediately after the event has ended and the results are final.

All Competitors will start in Class order starting with Class 1, 2, 3, etc and must be ready when called forward. There must be no speeding in the Paddock – <u>10 MPH MAX SPEED LIMIT!</u>

A large Spill Kit will be provided for the Paddock Area as per MSA Yearbook E 7.5
