Supplementary Regulations

- **1.** Enniskillen Motor Club Limited will organise a Clubman Special Stage Rally on Saturday 4th October 2014 to take place around the Forests of the Derrygonnelly area, Co Fermanagh.
- **2.** The meeting will be held under the General Regulations of the Motor Sports Association (incorporating the provisions of the International Sporting Code of the FIA), these Supplementary Regulations and any written instructions that the organising club may issue for the event.
- 3. Permit number 85205 has been issued for the event.
- **4.** This event is confined to registered members of the organising club, Enniskillen Motor Club Ltd, who hold a valid MSA Competition Licence or Motorsports Ireland Licence for the status of this Event or higher.
- **5.** All competitors must produce a valid Enniskillen motor club membership card at Documentation Scrutiny. The driver must also produce a valid current Driving Licence

 Both crew-members must produce a current competition licence, valid for the status and type of the event or higher. [See Chart 26 on page 141, MSA Yearbook 2014 for details of acceptable licences.

 See also H26.1.4 and H26.1.5]. A Co-driver may apply for an MSA Competition Licence for the event at Documentation Scrutiny by filling in an MSA Licence Application form and paying the appropriate fee made payable to the MSA UK. (UK resident ONLY).

 Also any competitor who is unable to produce a valid Competition Licence may, subject to approval

Also any competitor who is unable to produce a valid Competition Licence may, subject to approval by the MSA Steward, sign a Non-production of Licence Declaration and pay a non-refundable fine of £67.00 [H22.1.2].

- 6. The event is a round of the 2014 Enniskillen Motor Club Championship.
- 7. The programme of the meeting will be: Scrutiny Saturday 4th October from 8.00am until 10:30am at Derrygonnelly Autos, Derrygonnelly, Co Fermanagh. Any competitor not signed on at Documentation Scrutiny at Old Pals Bar, Derrygonnelly by 10:45 am on Saturday 4th October 2014 will be excluded as per R5.1.1. NB The organisers WILL NOT extend this time for any competitor. At scrutiny, cars will be examined for compliance with tyre and vehicle safety regulations as well as for class eligibility. Auxiliary lights must be fitted if to be used on the event. Entrants should have full knowledge of the cars as to its eligibility for the class entered. All vehicles must comply with MSA Technical Regulations Sections J and all of R46-R48.10.10 inclusive. A noise test will be carried out prior to vehicle scrutiny as per R4.1. First car starts 12:00 hrs.
- **8.** Cars will start at one minute intervals. The finish venue will be Old Pal's Bar, Derrygonnelly The event will contain 6 special stages with a total stage mileage of approximately 22 stage miles. Servicing will only be permitted in the designated service area. **Ground sheets must be used.** The stages will be timed to an accuracy of less than one minute in accordance with R31.1.3. The stages will take the form of 98% gravel roads.
- **9.** The event will consist of classes as follows: Class 1 – all 2wd cars up to and including 1400cc

Class 2 – all 2wd cars from 1401cc up to and including 1650cc, having not more than 2 valves per cylinder

Class 3 – all 2wd cars from 1401cc up to and including 1650cc, having more than 2 valves per cylinder

Class 4 – all 2wd cars from 1651cc up to and including 2100cc, having not more than 2 valves per cylinder

Class 5 – all 2wd cars from 1651cc up to and including 2100cc, having more than 2 valves per cylinder

Class 6 – Group N 2wd cars up to and including 2000cc

Class 7 - all 2wd cars over 2100cc

- **9.1** Cars eligible for Class 6 are those which are, or have at any time been homologated in Group N as defined in FIA Appendix J, also any series production car that is, or has been, available for general sale in Northern Ireland.
- **9.1.1** The standard specification of any model shall be determined by FIA homologation papers in the case of current and former Group N cars, and by manufacturers', or other workshop manuals in the case of all other cars.
- **9.1.2** In all cases, the degree of modification from standard shall be as provided for under FIA 2014 regulations for Group N.
- **9.1.3** The onus of providing eligibility for Class 6 rests solely with the competitor.
- **9.2** All vehicles must display a valid road tax disc. Current mot and road tax will be required. Each competing vehicle must have a valid Competition Car Log Book as appropriate to the individual event entered [R46.1.3].

Each competiting vehicle must carry, at all times, a red reflective triangle and an SOS/OK board complying with R25.4 & R48.10.9. Spot checks may be carried out at any time during the event to ensure compliance with this regulation – see Article 11.24 of these ASR's for penalty! It is strongly recommended that all competing cars carry a First Aid kit.

All competing vehicles must carry a self-contained spill kit, capable of absorbing minor spillages of up to 1.5 litres of vehicle fluids (see NI Championship Regulations, Article 5).

- **9.2.1** Only two-wheel drive normally aspirated cars are permitted to take part in classes 1-4 and 6-7.
- 9.3 The onus is on the competitor to enter the correct class.
- **9.4** Starting order will be based on information supplied on the entry form. The order of starting will be at the organisers' discretion, but to assist in seeding, entrants should note their previous results on special stage rallies since January 2011 on the entry form. *Once the entry list has been published, no discussion will be entered into regarding it.*
- **10.** Awards will be presented as follows:

1st overall - 2 trophies

2nd overall - 2 trophies

3rd overall - 2 trophies

1st in class - 2 trophies

2nd in class - 2 trophies (3 or more starters)

3rd in class - 2 trophies (6 or more starters)

Overall winners will not be eligible for Class Awards.

Special 50th Anniversary Awards (Bertie Fisher Trophies) will be awarded at the discretion of the organisers.

11. The entry list opens on publication of the Supplementary Regulations and closes on Friday 26th September 2014. **The entry fee is £190 Stg (€250 euro).** The closing date is the date of receipt of entries (not the date of posting). All entries must be made on the official entry form and accompanied by the appropriate entry fee (no post-dated cheques please). Entries by telephone, fax or e-mail will not be accepted.

12. RTA INSURANCE:

Drivers must have valid insurance covering them against liability for both personal injury to, and damage to the property of third parties on public road parts of the event. It is the drivers' responsibility to arrange such insurance and/or to extend existing insurance as necessary. Drivers will be required to sign and declare that they are covered by such insurance. Any failure to sign a declaration may mean that the car in question may not be permitted to start.

The Club has applied to Lockton Insurance for a blanket cover note under the Motor Sports Risk Services scheme. This will enable competitors who wish to avail of the scheme to buy third-party cover on road sections of the event as required by law and to comply with R5.1.2 and D12.3.6. To be eligible for this scheme, competitors must:

- 1 Be over 21 years of age and have held a full Driving Licence for a minimum of 6 months.
- 2 Not have had more than one fault accident in the last three years.
- 3 Not have more than six speeding points on their licence.
- 4 Have no physical or mental disabilities
- 5 No other material facts**
- ** ALL material facts MUST be disclosed. Material facts are those likely to influence the acceptance or assessment of your risk. Failure to declare material facts may lead to the insurers declaring the resultant cover null and void.

If you are able to comply with ALL of the above points, simply sign the declaration on the Insurance Signing-on Form at Documentation – no letter of acceptance is necessary.

If you are NOT able to comply with ALL of the five points above, you must apply for insurance at least three weeks before the event, as a letter of acceptance must be issued by Lockton Insurance before cover can be granted. To do so, complete a proposal form, available from the Secretary of the Meeting, or Lockton Motor Sports Risk Services by telephone on 0161 8283300, or on-line at www.locktonmotorsport.com. NO LETTER = NO START!

- 16. Provisional results will be published as soon as possible following the event (D 26.1.2).
- **17.** Any protest must be lodged in accordance with C 5.1 5.7 inclusive.
- **18.** Competitors will be supplied with a time card and details of all special stages at documentation. These documents will provide all the information necessary to enable competitors to comply with R28.1 and R33.1.

The use of subjective route notes will be permitted and they will be on sale from:-

<u>Patterson Agencies Ltd: Tel 44(0) 28 90844111 (Monday – Friday 9 – 5), or at the event.</u> Servicing will only be permitted in the areas specified by the organisers (R38.1). 'Chase/Support' vehicles will NOT be allowed. Penalty is exclusion.

- **19.** COMPETITORS WILL BE IDENTIFIED BY SIDE NUMBERS WHICH WILL BE PROVIDED BY THE ORGANISERS AND MUST IN PLACE ON THE VEHICLE FOR SCRUTINY.
- 20. Marking and penalties will be as follows:
- (a) Achieving a time on a Special Stage which is less than the bogey time BOGEY TIME
- (b) Achieving a time on a Special Stage which is more than the Target Time TARGET TIME
- (c) Achieving a time on a Special Stage which is more than Bogey but less than Target Time ACTUAL TIME TAKEN
- (d) Failure to leave a Special Stage start within 20 seconds of Due Start Time TARGET TIME
- (e) Making a false start on a Special Stage 1 MINUTE
- (f) Blocking a Special Stage * TARGET TIME PLUS TWO MINUTES
- (g) For each minute over Target Time on a road section or over Target Time in a service area 10 SECONDS
- (h) For each minute under Target Time on a road section 30 SECONDS
- (i) For each minute before or after Due Time at a Main Control (Out) 1 MINUTE
- (j) Completing a road section in less than 75% of the Target Time** 15 MINUTES
- (k) Failure to comply with a requirement of the road book (entering a Control Area more than once; incorrect direction of travel at a Control; incorrect route on a Special Stage) 15 MINUTES
- (I) Failure to comply with a reasonable instruction from an Official, provided warning is given that a penalty may be applied 15 MINUTES
- (m) Failure to surrender a Time Card to an Official when asked to do so 15 MINUTES
- (n) Excessive noise, damaged or ineffective silencing system** 15 MINUTES

- (o) Any other offence for which a penalty other than exclusion is to be imposed 15 MINUTES
- (p) Service vehicle failure to adhere to specified area EXCLUSION
- (g) Failure to attempt a Special Stage EXCLUSION
- (r) Exceeding Maximum Cumulative Lateness EXCLUSION
- (s) Failure to report at a Control EXCLUSION
- (t) Failure to provide proof of having visited a Control EXCLUSION
- (u) Failure to report at Controls in the correct order EXCLUSION
- (v)Breach of Regulation R46-R48 inclusive EXCLUSION
- (x) Breach of a statutory requirement concerning the driving of a motor vehicle EXCLUSION
- (y) Receiving assistance contrary to R38.1.2-R38.1.4 inclusive EXCLUSION
- (z) Failure to display or misuse of SOS/OK sign (R25.4) EXCLUSION FROM THIS AND ALL FUTURE EMC Ltd EVENTS AND MSA TO BE NOTIFIED (SOS/OK signs are to be of a durable and waterproof material
- * All other competitors affected by the blockage of a Special Stage will be credited with a time in accordance with R24.5 & R24.5.1& R24.5.2.
- ** Second offence EXCLUSION
- (aa) Restrictions on tobacco-related advertising will be imposed on events likely to be televised H28.1.1 H28.1.6 inclusive.
- **21.** All other General Regulations of the MSA apply as written, except for the following which are modified: R38.1.2 R38.1.4 inclusive.
- **22.** To be classified as a finisher, a competitor must report to all controls listed in the road book/time card and report to the Final Control within his/her maximum cumulative lateness, with the car in which he/she started.
- **23.** In the event of a tie, the competitor who has the greater number of faster stage times will be the winner. Failing this, the competitor with the faster time on the last stage will be the winner, then the penultimate stage, and so on until the tie can be resolved.
- 24. Maximum cumulative lateness will be 15 minutes.
- **25.** Competitors will be required to reduce lateness by either foregoing or reducing any period of time provided for remaining at a Control or Official Halt. These Controls/Official Halts will be designated in the road book.
- **26.** Controls and Checks will open 15 minutes before the Due Time of arrival of the first car and close 15 minutes after the Due Time of arrival of the last car.
- **27.** A competitor who practices, carries out reconnaissance or otherwise examines a special stage (or who uses another person or persons to do so on his/her behalf), will be excluded from the competition and reported to the MSA as per R26.7. In enforcing this regulation, the organisers will, if necessary, employ the assistance of the local Police, landowners in addition to their own officials. This will be strictly enforced.
- **28. EVENT SAFETY WILL BE A PRIORITY. IT IS COMPULSORY TO ATTEND ANY DRIVERS' BRIEFING BEING HELD.** To this end, ten competitors' numbers will be drawn at random at the briefing. Any crew whose number is drawn and who are **not present will incur a FIVE minute penalty.**
- 29. Interpretation of regulations:

It is not duty of any Marshal of Official to interpret any regulation or any written instruction to a competitor or to explain the meaning or effect thereof. It is the responsibility of the competitor to read and understand the regulations and other written instruction.

30. Abuse of officials:

Any competitor, or member of a service crew, who directly or indirectly abuses an official of this event either verbally or by any other means will be excluded and reported to the MSA.

31. Organiser's liability:

The organisers decline liability in any accident or situation caused by, or to competitors, and the competing cars during the whole of the event. The organisers also decline any liability for breach of the laws and regulations of Northern Ireland covered by the itinerary. Competitors shall be held responsible for any accident on public or private land. Competitors must declare to the organisers any breach of laws in which they may be involved and shall also declare to the organisers the particulars of any incident from which liability may arise. They shall have no claim against the organisers arising out of any action of the organizers, their servants or officials, during the course of the rally.

32. Advertising:

Competitors must provide a space of 645 cms² on each side of the two front doors of the competing car for additional sponsor advertising [H29.1.2] if required.

If the event is being televised, competitors are reminded that there are strict legal restrictions on the advertising of tobacco [H28.1.6] and alcohol. If you require more information regarding this, please contact the Secretary of the Meeting. (Ref SR's item 20 aa).

Nothing in this clause is intended to or shall be deemed to exclude or limit liability for death or personal injury. To the fullest extent permitted by law I agree to indemnify and hold harmless each of the Parties in respect of any loss or damage whatsoever and howsoever arising from my participation in the Event.

"I declare That to the best of my belief the driver(s) possess (es) the standard of competence necessary for an event of the type to which the entry relates and the vehicle entered is suitable and roadworthy for the event having regard to the course and the speeds which will be reached."
